J. Meader *motioned* to approve the May 27, 2014 meeting minutes as presented. S. Brodeur *seconded. All in favor; motion carried.*

Public Participation: None

Old Business:

Brooklyn Farmers Market signage for parking lot: S. Karro reported that the signage, along with a barrel provided by J. Meader, was used at last week's market. Frank Anastasio has yet to provide any feedback.

Table cover with logo purchase: S. Timmons reported that none of the three local businesses have responded to her e-mail inquiries. She will telephone them or visit them in person. On a separate note, she has spoken with the Killingly Historical Society regarding their use of release forms for photos. They generally do not use them; their policy is to give credit to the person who provided them with the photo. S. Timmons suggested that, for the purposes of the History of Agriculture in Brooklyn project, the commission model their consent form after that used by the Natural Resources Conservation Service.

Committee report for History of Agriculture in Brooklyn: S. Karro reported that the concept of a four to five page summary was discussed but it was ultimately felt that more detail is warranted. A wide variety of topics was discussed, including Israel Putnam; the transition from subsistence farming to commercial farming; the grist mills on Blackwell's Brook; the three flower-growing farms on Allen Hill Road; the grist mill at Lawton's Pond; and dairy farming. The next step is to conduct interviews.

S. Timmons noted that the commission may wish to consider other media in addition to the printed word. S. Karro suggested that the commission could do something along the lines of the Town of Canterbury kiosk. L. Brodeur noted that the end product could be published on the town's website. S. Brodeur noted that the project could incorporate audio excerpts from the interviews.

S. Karro will compile a written report of the committee's initial meeting. S. Brodeur suggested that, for the purposes of conducting future interviews, the commission consider purchasing a digital recorder with remaining funds from this fiscal.

Review other old business from May meeting: S. Karro noted that the payment to the Farmer's Market has been processed.

New Business:

Report from Lou on Animal Rescue Training: The event was cancelled due to a lack of participation.

Back-To-School Barbecue: The commission discussed participating in this event. J. Meader's display can be used. S. Brodeur noted that Deb Tanner may have flyers that can be used. S. Timmons suggested that it would be a good idea to have something geared specifically to kids. S. Brodeur will check with Deb Tanner for kid activity ideas.
