Minutes from January 2014 approved.

New Business:

Northeast CT Farmers Market Association

Betsy Molodich (president) and Frank Anastasio (Brooklyn market master) shared the Brooklyn market situation at the Ocean State Job Lot plaza.

-Farmers Market in Brooklyn has grown in sales. Getting very busy.

-They do need fruit (Palazzi has pulled out). C.Langevin shared that he has an orchard rent free for someone to maintain and harvest. Benjamin's Orchard a possibility?

-The commuters who park in the market space Wed AM, forget and create a challenge.

- Parking is the most important market requirement. 60 spots are needed.

- The Putnam Monday has a Community Supported Market.

- A building would be attractive but would be weighed against the loss of commercial businesses nearby and convenient parking.

- Entertainment shows up to get exposure in Putnam (electricity available)

- Sky Johnson is applying for a mobile food truck using local foods.

- Non-profits are selling baked goods.

- Need help on Saturdays trying to deliver surplus vegetables to the food pantry, Monday.

- SNAP: Wireless access is \$37/ machine. Each location needs a separate machine.

Brooklyn pays 17% in fees for SNAP. Danielson and Putnam received more food stamps than Brooklyn, so percent of sales in fees is less.

-Wholesome Wave subsidizes Putnam market purchases by WIC families by doubling their purchases.

- Senior Citizen vouchers are also in Putnam.

- Public transport brings senior citizens to Putnam.
- Need to ask if public transit would bring non-drivers to Brooklyn market.
- Permanent signs are needed at Job Lot to keep out commuters.

The Ag Commission asked if another site would be attractive, such as the Don Francis Recreational Park. J. Meader questioned if there is sufficient parking at the town property. The Putnam structure was discussed. Lots of grant money and in-kind contribution. F. Anastasio reminded us of the structure maintenance costs for the town.
