- a. Elementary School Principal

The report was included in the Board of Education members packets.

Ms. Rotella presented a PowerPoint presentation regarding common core curriculum alignment at the elementary school. She informed the Board of Education members what has been done in the past three years to develop a curriculum that aligns with the common core state standards. Year one was considered an awareness phase; the differences between the Connecticut Mastery Test and the Common Core State Standards was examined. A Curriculum Committee was established as well as a Professional Development Committee.

In year two, one teacher per grade level attended the Consortium. It was decided that all grade levels would complete a pilot for the My Math and Envisions in the 2013-2014 school year.

In year three, a new way of doing things was implemented with the help of technical assistance. The technology helped with communication and collaboration. The STAR assessment program was implemented in grades 1 through 8.

Mrs. Nault informed the Board of Education members that the second grade has been working on written responses in both reading and math. Examples of the curriculum were presented.

Ms. Rotella stated that she feels they have a good understanding of the Common Core State Standards and the interventions needed for student success. She informed the Board of Education members that Common Core State Standards have been being implemented for the last three years and each year they have been refining and revising the curriculum in a collaborative manner. At this time, the curriculum has been started for language arts, however, it is not done in every area.

The report regarding spring sports was reviewed. Dr. Berry informed the Board of Education members there is no softball team this season due to lack of interest.

- e. Superintendent
 - Full Day Kindergarten

Dr. Berry stated that 100 letters were sent to parents of preschool students asking their opinion concerning a full day kindergarten program. Of the 100 letters, 57 were retuned. 52 responses indicated they would like a full day program. Five responses indicated they did not support a full day program simply because they were not ready to give up time with their youngster yet. All of the letters that were returned had positive feedback and appreciative comments from parents that they were given the opportunity to offer their opinions.

2014-2015 Budget

Dr. Berry informed the Board of Education members that she spoke with the Board of Finance and informed them that at this time she is not able to finalize the 2014-2015 budget due to ongoing negotiations with Local 1303. There will be a budget hearing at the end of May and a town meeting on the budget on June 5th.

Dr. Berry also informed the members that the insurance rate increase was at 18%, and then reduced to 12.78%. Dr. Berry is confident that it will be between 9% and 10%.

Mr. Ives would like the town employees to join the school employees on an insurance plan in the hopes of getting a lower rate for more people.
