b) Discussion and review PoCD 2011-2020- Diane spoke with Jana and asked how to address concerns or questions. Jana said communications could be via email. Jana called this afternoon and stated she'd updated the Plan to include what's already been done and added a couple of items. The implementation recommendations for the Conservation section had a background, objectives and maps for historical and archaeological resources, unique and natural features, open space, water wetlands, potential aquifer resources, habitat and forest. It's online for anyone to find. Diane asked Richard Calarco (Corrected) if this is the type of thing we need to do for the new plan. Richard stated Conservation needs an overall master plan for land usage. Discussion took place.

Parks and Recreation #11 - Disc golf course created. Discussion took place around maintenance.

New #15 – Establish and support existing and future sustainable plants and trees on town owned land. For example, rain gardens, butterfly gardens. Priority 1. People involved should be members of Conservation, Agriculture, Public Works, Parks & Recreation. Ongoing.

New #16 – Open space and natural resource conservation – To maintain and enhance and expand town trails for walking, hiking and non-motorized activities. People involved should be members of Conservation, Public Works, Parks & Recreation. Ongoing. Ask Jana about grants for these projects.
