4. Old Business

a. Training

Mr. Skene explained that some websites are being updated regarding Emergency Management and should be completed withing the next month, then we can get some things set up. He would like to get one or two Board Members on the Web EOC.

b. CERT Training

Mr. Skene explained that there is no new news, but they are doing one in Coventry and are trying to do one locally.

c. EMPG Grants

i. 2022 grant

Mr. Skene explained that once he gets the needed documentation, he will meet with Colchester to get the grants completed.

ii. 2021 grant

Mr. Skene explained that once he gets the needed documentation, he will meet with Colchester to get the grants completed.

iii. Supplemental 2020 Grant

g. ARPA Grant - Radios

Mr. Skene explained that some of the radios have already come in and others will be coming in very soon. A company in Willimantic has been doing the installations. Installations should take place this summer for all of the Town and emergency vehicles.

5. New Business

a. Storms and recent activities

Mr. Skene explained that there have been some minor storms coming through, but nothing of any significance or importance. There was discussion.

b. Day Street

Mr. Skene explained that Mr. Tanner is keeping the residents of Brooklyn informed on the situation on Day Street. There was supposed to be a meeting last Friday (regarding repositioning telephone poles to the other side of the street) with Eversource, Mr. Rukstela and Mr. Skene, but it was cancelled (not rescheduled as of this date).

c. New EMPG Grant due 5/15/2024

Mr. Skene explained about this grant (up to \$25,000 for updating EOC) and will provide information to the Board Members. There was discussion.

d. Statewide Emergency and Planning and Preparedness Initiative 6/12/2024.

Mr. Skene explained that, every year, they do a drill throughout the State. He will try to do it at the Town Hall (9 a.m. to 12 p.m.).
