Also Present: Joe Voccio and Gil Maiato


1. **Call to Order:** Austin Tanner called the meeting to order at 7:46pm.
Lou Brodeur made a motion to move Bob Lee from an alternate member to a regular member for the purpose of a quorum. Austin Tanner seconded the motion. Motion passed 3-0.
2. **Approve Previous Minutes:** Lou Brodeur made a motion to approve the minutes of 10/14/21 as presented. Bob Lee seconded the motion. Motion passed 3-0.

meeting at 6:30pm beginning February 10th. Austin Tanner seconded the motion. Motion passed 3-0.

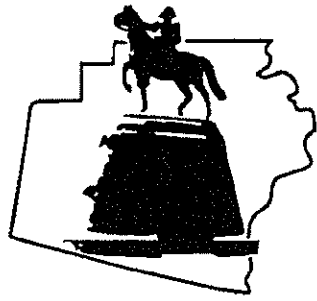
8. **Public Comment:** Gil Maiato would like to see a new sign at the transfer station with the hours. He expresses hope that the new attendant will work out.
