ORDINANCE REQUIRING TOWN MEETING APPROVAL OF AGREEMENTS, CONTRACTS OR LEASE OF TOWN OWNED PROPERTY

Town Meeting approval shall be required before the Town of Brooklyn enters into any agreement, contract or lease of any town owned property or equipment with the value exceeding Five Thousand and 00/100 (\$5,000.00) Dollars.

ORDINANCE REQUIRING TOWN MEETING APPROVAL ON THE SALE, LEASE OR TRANSFER OF TOWN OWNED REAL PROPERTY

Town Meeting approval shall be required before the Town of Brooklyn sells, leases or transfers any real property owned by the Town of Brooklyn.

This ordinance shall become effective fifteen (15) days following publication of its approval thereof in a newspaper having a circulation in the Town of Brooklyn.
