The Brooklyn Board of Education held its regular monthly meeting on December 18, 2018 in the Central Office Community Room. 7. Administrative Reports:

a. Current budget balance

The budget was reviewed by Mrs. Buell. 38% of the budget has been expended, 54% of the budget has been encumbered, 8% of the budget has not been encumbered at this time.

Mrs. Buell stated that there has been a significant savings of \$8,000 with electricity in a month due to replacing all the light bulbs in both schools to LED bulbs. There will be even more savings once the schools go solar.

b. Current Grant Report

Mrs. Buell stated not much has changed with the Grants in process and Federal Grants are on track.

c. High School Tuition Report

Mrs. Buell explained how the High Schools bill their tuition. Woodstock Academy bills are based on the number of students enrolled October 1st of the previous year. Killingly High School bills are based on October 1st of the previous year, but based on the actual number of students attending. At this time, there's a surplus of approximately \$169,000.

d. Enrollment Report

The Enrollment Report was reviewed by Mrs. Buell. There is a decrease of 1 student from last month, but still greater than last year at this time.

Mr. Otto questioned why the Out of District Students weren't included in the total. Mrs. Buell explained these students are Special Education students that are not attending Brooklyn Schools currently.

8. Board of Education Committee Reports

a. Development of a Solar Building Committee

Mrs. Lyons stated that the Selectmen would be the one to appoint members of the Solar Building Committee. Mrs. Buell, on behalf of the Board of Education, will send a letter to Selectman Ives stating that Mr. Richards and Mrs. Lyons are interested in being on the Solar Building Committee.

b. Transportation Committee Meeting to discuss traffic flow around BES/BMS

Mrs. Lyons is interested in being on the Transportation Committee Meeting. Mrs. Buell believes parents would want to be involved as well, especially parents that are in the parent pick-up/drop-off line on a daily basis to express their ideas.

11. New Business

a. Recruiting & Hiring Solution Services Update

Mrs. Buell gave an update on the multiple year contract with Frontline as well as providing information on what EASTCONN offers. EASTCONN has the same software and might be cheaper to go through EASTCONN. There was discussion about the possibility of applicants being confused with being hired by EASTCONN instead of Brooklyn Public Schools. Mrs. Buell stated there is a package deal if the Board were to decide to go through Frontline, since the schools are using other software from Frontline. Using this system will have the benefit of a larger teacher pool. Mrs. Buell feels we need to move forward.

Motion was made by Mrs. Genna to enter into agreement with Frontline for Recruiting & Hiring Solution Services for the remainder of this year and next year.

(Lyons/Richards) Unanimous vote to approve

b. First review of the 2019-20 School Calendar

Mrs. Buell shared that she has EASTCONN's calendar, but Woodstock and Killingly's aren't ready yet. There was a discussion in regards to comments made that parents like the preset snow days and trying to have the students out earlier in June. Mrs. Lyons mentioned about the possibility of having Columbus Day as a Professional Development Day for teachers. Mr. Otto mentioned that Columbus Day is a state holiday. Mrs. Buell doesn't want to touch Columbus Day with it being a state holiday. Mrs. Buell will try to follow the same calendar in place this year for next year's calendar when putting together a few drafts for the Board to consider.
