1. Determination of quorum and opening of meeting: Drew Dionne called the meeting to order at 7:15pm. Chairman Otto is experiencing difficulties logging into the meeting.

2. Public Comment: None

3. Action on Minutes of December 16, 2020 Meeting: Sandy Brodeur made a motion to approve the minutes of 12/16/20 with one correction. Lou Brodeur was in attendance. Ken Dykstra seconded the motion. Motion passed 5-0.

4. Old business

a. Review of Letters from Atty Ritter on expenditure of unexpended bond funds: The letters were sent to members but not all were able to review. Rick states he addresses both scenarios; 1. If it is done through BANS and 2. If done through budget. Sandy does not understand what the schedule is trying to show. Rick will speak with Attorney Ritter and have him attend a meeting to explain and discuss.

b. Decision by Board of Selectmen on participation in NECCOG's Human and Veteran's Resources Program and discussion of any necessary action by the BoF: The Board of Selectmen have not voted on this yet, it will be on the next meeting agenda.

c. Discussion, if necessary, of any BoF action required related to the PV electricity program at the Brooklyn Schools: No action is needed from this board.

d. Progress Report related to a programmatic display of income and expenses within the Recreation Department: There are no programs in progress currently. Sandy Brodeur recalls a report Mr. Ives was going to send. Rick states he sent that the month before and has nothing different to show.

e. Update on status of revaluation: This is completed but not signed yet. Kathy is going to come back to sign next Wednesday.

f. Update on fixed asset reporting (in-house vs. vendor report): Stephanie Levin states we received the report for 2020 and was submitted to the auditor. Field Service is no longer doing our fixed assets. We purchased software to do this in house. The installation and training will begin soon. The initial cost was approximately \$2,100 and going forward, it will be \$760 a year. We currently have asset tags, we will continue to use those and will obtain the spreadsheet from Field Services and will upload to the new software.

g. Update on schedule for developing '21-'22 budget: Rick states the Town is on track and working on the budget.

h. Audit Status: The report should be to us next Wednesday. The audit company is stating this is a priority and should be done for the end of the month.

i. Status of telephone bill audit: We received our Spectrum bill and had a credit of \$3,000. Going forward, we should see an annual savings of \$700 for the Town a year and the school a savings of \$600 a year.

j. Status of inland wetlands and PZC revenues - separation of state fees: Some fees have not been paid over the last couple years. They were reported but not sent to the State. Stephanie received quarterly reports dating back to April of 2017. This will be cleaned up and developing a spreadsheet to record going forward.

k. Other Old Business: None

5. New Business

a. Update on Louise Berry Drive Condominium development, if any. There has been no BoE meeting since the last BoF meeting: This is in process; it is in Wetlands currently. This will most likely go through the summer. It will probably spend a lot of time in Planning & Zoning.

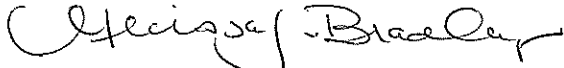
b. Other new business: None
