Regular Meeting Minutes
Thursday, October 29, 2015
6:30pm Clifford B. Green Memorial Center

Present: Rick Ives, Bob Kelleher, Joe Voccio and Melissa Bradley; Recording Secretary

Also Present: Aaron Kerouac, WINY radio and the Bulletin

1. Call to Order: Mr. Ives called the meeting to order at 6:31pm.

2. Approve Previous Minutes: Joe Voccio made a motion to approve the previous meeting minutes of 9/24/15 as presented. Bob Kelleher seconded the motion. Motion passed 3-0.

3. Public Comment: None

4. Appointments:

- Zoning Board of Appeals: Bob Kelleher made a motion to move and accept the resignation from James Grzesiak with regret and thanks for his participation. Joe Voccio seconded the motion. Mr. Ives states he no longer lives in Town. Motion passed 3-0. Joe Voccio made a motion to appoint Mark Benard as regular member with term expiring 01/01/2019 for discussion. Bob Kelleher seconded the motion. Mr. Voccio sees a possible appearance of a conflict of interest as Mr. Benards profession is as a realtor and developer. Mr. Ives agrees with the perception but does not feel he should not be considered. He would have to recuse himself if a conflict arose. Mr. Kelleher points out there is a similar conflict on the Planning & Zoning commission. Motion passed 3-0.
- BEMHS: Bob Kelleher made a motion to reappoint Kevin Filchak with term expiring 12/13/2018 and reappoint Tom Rukstela with term expiring 10/27/2017 and Lou Brodeur with term expiring 10/27/2016. Joe Voccio seconded the motion. Mr. Kelleher is confused on the reappointment dates and would like them checked into to ensure they are correct. Motion passed 3-0.
- 2015-16 Budget Discussion: The board will continue to review the budget each month.
- 6. Capital Committee Discussion: Mr. Ives refers the highway and recreation vehicle to the capital committee seeking a recommendation on how to fund them. Mr. Voccio will schedule a meeting to review the trucks and also to review the capital report when completed.

7. Discussion on forming a committee for CT Clean Energy: Eversource offers a program of in-kind grants on how you improve your consumption. Our costs need to be benchmarked and monitored. A committee is needed to spear this task and the school should be involved as well. Mr. Kelleher agrees to proceed with the task and will bring committee member suggestions to the next meeting.

8. Construction Projects Update

- Sidewalk project to Wal Mart is approved and we are waiting on the State.
- Rose Roof project should begin during the April vacation. The State requested additional
 materials and they were sent. An amendment was made and also sent. Bids should go
 out mid-November.
- 9. Zoning Enforcement Update: Brooklyn Sand and Gravel is still in discussions with the ZEO. Mr. Ives has been in touch with Mr. Jolley and the Trahans have been kept abreast. A decision should be known in the next three or four weeks.
- 10. Traffic Signal Update/ Route 6 & Allen Hill: A resident requested a left turn signal at the intersection of Route 6 and Allen Hill. Mr. Ives contacted the state and they are reviewing the request. Mr. Kelleher questions who would pay to change the traffic light. Mr. Ives will have to check into it.

11. Liaison Reports:

- Resource Recovery: Mr. Ives met with the current recycling company and claimed they
 are not charging enough for the bi-weekly collection and requested another \$1,000 a
 month. Mr. Ives was not comfortable with this and the current contract with the
 current price is in place for a couple more years. The commission signed the contract
 acting as an authority, but they no longer have that ability. This concerns Mr. Voccio and
 anticipates it will be taken care of.
- Board of Education: Mr. Voccio states the board met and it was the last meeting with outgoing members. Fire alarms are being tested and will have an update in mid-November.
- Board of Fire Commissioners: The commission discussed truck replacement and is working on a new schedule. A truck will be needed for 2017/18 fiscal year. Mr. Voccio requests an updated schedule from Highway as well.

12. Other Business: None

- **13.** Approve Bills: Mr. Voccio made a motion to approve the bills in the amount of \$283,254.31. Bob Kelleher seconded the motion. Motion passed 3-0.
- 14. Single Family Dwellings: No discussion
- 15. Calls for Service: No discussion
- 16. Public Comment: None
- **17. Adjourn:** Bob Kelleher made a motion to adjourn the meeting. Joe Voccio seconded the motion. Meeting adjourned at 7:15pm.
