Board of Selectmen Regular Meeting Minutes Thursday, February 25, 2016 6:30pm Clifford B. Green Memorial Center

Present: Rick Ives, Bob Kelleher, Joe Voccio and Melissa Bradley; Recording Secretary

Also Present: David Fuss, Gene Michael Deary and Aaron Kerouack

- 1. Call to Order: Mr. Ives called the meeting to order at 6:39pm.
- 2. Approve Previous Minutes: Joe Voccio made a motion to approve the minutes from January 28, January 30 and February 20, 2016. Bob Kelleher seconded the motion. Motion passed 3-0. Joe Voccio made a motion to approve the minutes from February 6, 2016. Rick Ives seconded the motion. B. Kelleher abstained. Motion passed.
- 3. Public Comment: None

#### 4. Appointments/Resignations

- Bob Kelleher made a motion to accept the resignation from Lyn LaCharite from EDC with regret and thanks for her long service. Joe Voccio seconded the motion with gratitude and sincere thank you for her service. Motion passed 3-0.
- Bob Kelleher made a motion to accept the resignation from Don Francis from P&Z with regret. Joe Voccio seconded the motion. The board recognizes Don's length of service and involvement. Mr. Ives states there is something in the works to show gratitude. Motion passed 3-0.
- Joe Voccio made a motion to appoint Jeryl Mohn to Planning & Zoning as an alternate member with a term expiring 10/01/2016. Bob Kelleher seconded the motion. Mr. Voccio states this is a great opportunity for the board with Mr. Mohn's credentials. Mr. Ives states he originally requested Inland Wetlands but then chose P&Z. Motion passed 3-0.
- Joe Voccio made a motion to appoint Jules D'agostino to Planning & Zoning as an alternate member with a term expiring 10/01/2016. Bob Kelleher seconded the motion. Motion passed 3-0.

- Bob Kelleher made a motion to appoint Demian Sorrentino to Inland/Wetlands as a regular member with a term expiring 02/01/2019. Joe Voccio seconded the motion. Motion passed 3-0.
- 5. Discussion/Action on MOU between the Town of Brooklyn and the Eastern CT Conservation District: White Brook runs from Darby Road to Pomfret and into Mashamoquet Brook. White Brook's water quality failed and the issues were caused by faulty septic systems. The Eastern CT Conservation District would like to enter into a MOU with Brooklyn that would provide a rebate of \$2,000 to residents who systems were in need of the repairs. The resident would make the repairs and would then receive the rebate. The rebate does not need to be paid back and would cause no liens on the property. Bob Kelleher made a motion to authorize the First Selectman to enter into the MOU between Brooklyn and the Eastern CT Conservation District as presented in the attached. Joe Voccio seconded the motion. Motion passed 3-0.
- 6. Discussion/Action to Set Town Meeting: Mr. Ives has not received all the necessary requirements from Ms. Larrow regarding Grandview Terrace. He does not see the need to go a Town Meeting for just the Revenue Collector's ordinance at this time. Bob Kelleher made a motion to table item #6. Joe Voccio seconded the motion. Motion passed 3-0.
- 7. Discussion on NECCOG Regional Incentive Grants: Mr. Ives will be receiving via email, and will forward, a list of the grant requirements with descriptions and an information sheet on each one. This will be discussed after review.
- 8. Discussion on Grand List: There was an adjustment made due to an accounting error from the assessment of Eversource. It is now down 1.69. Appeals will be coming in March, more adjustments may be made.
- **9. Discussion on 2015-16 Budget:** Budget seems to be on track. One purchase of sand had to be made. Mr. Ives will ask the Board of Finance where to fund the expenditure.
- 10. Discussion on 2016-17 Budget: There are no changes at this time and the budget workshop scheduled for Saturday will be cancelled. The auditors are filing another extension for two weeks. The next budget workshops will be March 12, 19 & 26<sup>th</sup>. The Board of Education would like to present their budget to the Board of Finance on April 13<sup>th</sup>.
- 11. Ethics Update: No update at this time.
- 12. Resource Recovery Update: Mr. Ives received an opinion from the attorney regarding options. Mr. Ives will forward to the Selectmen. A special meeting will be held on March 17<sup>th</sup>.
- 13. Calls for Service: No discussion
- 14. Single Family Dwellings: No discussion
- 15. Approve Bills: Joe Voccio made a motion to approve the bills as presented to the Board of Selectmen on 2/23 and 2/24 as reviewed and signed off. Bob Kelleher seconded the motion. Motion passed 3-0.

#### 16. Other Business:

- Mr. Ives will be attending a public hearing at the legislative office building to repeal the 1931 Special Act concerning the Board of Education on Monday. The new bill is not worded correctly and needs to address more.
- There is new aerial photography of CT being done and will be very helpful to the Town.
- Mr. Kelleher has a conference call with the architect at 11am in the morning to put a schedule together for the roof.
- Mr. Voccio reports the Board of Education had a preliminary budget meeting. It was presented by Sherry Holmes and she did a good job.
- Mr. Voccio will be getting availability to hold a capital meeting next month.

#### 17. Public Comment:

- Mr. Kerouack discusses public commentary and how it is perceived.
- 18. Executive Session: Joe Voccio made a motion to enter into executive session at 7:41pm to discuss the purchase of property and invites Board of Finance liaison Gene Michael Deary to join the discussion. Bob Kelleher seconded the motion. Motion passed 3-0. Executive session ended at 8:05pm.
- 19. Adjourn: Bob Kelleher made a motion to adjourn the meeting. Joe Voccio seconded the motion. Meeting adjourned at 8:05pm

## MEMORANDUM OF UNDERSTANDING BETWEEN THE TOWN OF BROOKLYN, CT AND THE EASTERN CONNECTICUT CONSERVATION DISTRICT

This MEMORANDUM OF UNDERSTANDING (MOU) is hereby made and entered into by and between the Town of Brooklyn, CT, hereinafter referred to as BROOKLYN, and the Eastern Connecticut Conservation District, hereinafter referred to as ECCD.

#### A. PURPOSE:

The purpose of this MOU is to develop and expand a framework of cooperation between BROOKLYN and ECCD, regarding an US EPA Clean Water Act grant to supplement the cost of septic system replacements in Pomfret and Brooklyn, CT.

#### B. ECCD SHALL:

Prepare priority maps for properties in Brooklyn determined to have high and medium priorities for septic system upgrades along White Brook in Brooklyn based on criteria agreed upon between CT Department of Energy and Environmental Protection, CT Department of Public Health and ECCD;

Contact the property owners in those areas to alert them of environmental and public health concerns regarding failing and/or non-compliant septic systems and the potential to get financial assistance for upgrading their septic systems;

Supply property owners with information regarding the Brooklyn Housing Rehabilitation Program (HRP) and potential funding assistance for income eligible residents of Brooklyn;

Prepare outreach materials with input from the Northeast District Department of Health, the CT Department of Public Health, CT Department of Energy and Environmental Protection and the US EPA for distribution to area residents;

Coordinate a workshop for homeowners on how to maintain a septic system and signs that a system is failing or not code compliant with Section 19-13-B103 of the CT Public Health Code;

Coordinate with HRP and the Northeast District Department of Health to determine if the existing system on the property is in need of replacement due to a system failure or non-compliance with Section 19-13-B103 of the CT Public Health Code;

Provide a rebate of \$2000.00 to any property owners within the identified priority areas that voluntarily upgrades their septic system to a system compliant with Section 19-13-B103 of the CT Public Health Code standards regardless of whether they meet the criteria for financial assistance through other programs.

#### C: BROOKLYN SHALL:

Continue to participate in the HRP;

Be provided an opportunity to review outreach materials prior to their distribution to the general public;

Assist with education and outreach for this project by coordinating meetings with ECCD and BROOKLYN staff and commission members;

Assist with education and outreach related to this project to the public through electronic and other outreach means;

Sponsor an education and outreach event on septic system maintenance and care by providing meeting space and/or publicity.

D: IT IS MUTUALLY UNDERSTOOD AND AGREED BY AND BETWEEN THE PARTIES THAT:

- 1. This project agreement will run through a contract period ending September 30, 2018, or until funding available through the ECCD rebate program is exhausted.
- 2. An onsite wastewater disposal system must meet criteria as a failing system or non-compliance with Section 19-13-B103 of the CT Public Health Code in order to be eligible for funding assistance through HRP.
- 3. <u>MODIFICATION</u>. Modifications to this agreement shall be made by mutual consent of all parties, by the issuance of a written modification, signed and dated by authorized officials, prior to any changes being performed.
