Joseph Cooper, Chair, called the meeting to order at 7:05 pm

- 1.) Roll Call Joseph Cooper, Pam Childs, Ron Panicci, John Harris and Mike Barry
- 2.) Approval of Meeting Minutes of March 4, 2013 Mike Barry made a motion to accept the March 4, 2013 Meeting Minutes as presented. Ron Panicci second the motion. Motion carried with one abstention by Pam Childs.

Mike Barry second the motion. Roll Call vote - Mike Barry, Pam Childs, John Harris, Ron Cooper.

2. Should the Recreation Director be using the Town vehicle for programs he gets paid extra on top of his salary, it is part of his job and he uses Town vehicle or it is extra job and so he should not use Town vehicle?

Response:

Joe Cooper made a motion to stating: No he should not be using the Town vehicle for other jobs. John Harris second the motion.

Ron Panicci does not feel the question can be answered. Pam Childs feels the question is too vague.

John Harris made a motion to rescind the prior motion to answer Question 2. Ron Panicci second the motion. Motion carried unanimously.

3. When running an extra activities program, should his compensation be set excessively high?

The Commissioner's agreed that compensation should not be set excessively high.

John Harris made a motion to approve/adopt his revised Board of Ethics reporting of alleged violations Complaint Form (revised 5/6/13). Motion second by Ron Panicci. Motion carried unanimously. See Attached.
