It's July and you know what that means! Barbeques, pool parties, and taxes!

The first installment for real estate, personal property taxes, and sewer taxes are due this month. Also motor vehicles and East Brooklyn Fire District taxes are due this month. You can pay your bills three different ways:

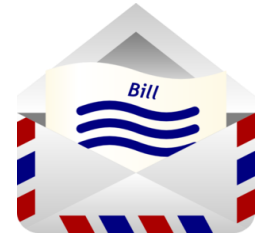

- ☀ You can mail in a check to PO Box 253, Brooklyn, CT 06234.
- ☀ You can pay online with a credit card (2.50% fees for a credit/debit card, \$3.95 fee for a Visa Debit Card ONLY, and \$2.00 for an electronic check).
- ☀ You can also come into the office and pay in person with check, cash, or card (fees still apply if you pay in the office).



The due dates for this year's taxes are:

July 1st – August 1st

October 1st – November 1st

January 1st – February 1st (Friday)*

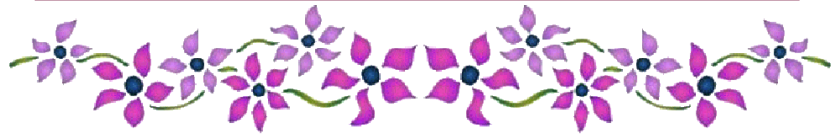
April 1st – May 1st

* Please note that the Town Hall will be closed on Friday, February 1st, but you can bring your payment to the post office and it can be postmarked with the February 1st date on the envelope.

Please check all of your tax bills and ask any questions that you have before paying the taxes. It makes it easier on you and us!

Sewer Usage Bills are printed on **green paper**, so as not to be confused with the Fire District Tax Bills that are printed on yellow paper.

The mill rate for the 2017 Grand List tax bills is 28.09.



Tax Bills are now Online!

Whether you need information for income taxes or to see what you owe, you can now view your tax bills online. Here is how:

☀ Go to www.brooklynct.org



☀ Staying on the home page, scroll down until you see three yellow buttons.

☀ Click on "Online Payments." It will bring you to a link, click on the link.

☀ You will be brought to the search page. Type in your last name space first initial (ex. John Doe would type in Doe J).

☀ You will be able to see your tax bills, date(s) of payment, and how much you paid to the Town of Brooklyn during a calendar year. You can also print out your tax bills for your records.

☀ **The Assessor's Office will be conducting Building Permit assessment inspections July 1st through September 27th for the October 1, 2018 Grand List. Please note: that if you have recently acquired your property you will receive a notice of Sales Inspections so we may maintain accurate assessment data.**



☀ **The Renter's Rebate Program** continues until Monday, October 1st, 2018. You or your spouse must be 65 years of age or older or over 28 and totally disabled through Social Security. Applicants must submit their SSA 1099 from Social Security and proof of any other income, Federal Income Tax form (if you were required to file), rent receipt and utilities for the entire 2017 year. **All information must be for 2017 year.** Income cannot exceed \$43,000 for married and \$35,300 for single.

☀ **Board of Assessment Appeals** will meet Thursday, September 13, 2018 from 6:30-7:30pm for Motor Vehicles only.

☀ **PA 490 Applications** are taken in the Assessor's Office beginning September 1st, 2018 until October 31st, 2018. Please check our website for applications and guidelines. Please note: for Forestry a signed & certified forester's report must be filed with the Assessor by October 1st, 2018. Our website also has a listing of Certified Foresters.

☀ **Personal Property** forms will be mailed by September 27th, 2018 and are due November 1st, 2018 (must be postmarked by November 1st, 2018).

☀ **New Commercial Truck** applications must be completed and filed by November 1st, 2018.

☀ **Annual Farm Building Exemption** forms need to be **notarized** and filed between September 1st and November 1st, 2018.



☀ **Totally Disabled/Handicapped Vehicle Exemption** forms must be filed by November 1st, 2018.

☀ **The Additional Veteran's Program** ends Monday October 1st, 2018. You must provide all income for 2017 including a Federal Income Tax for if you were required to file.



☀ **Honorable Discharge** for new Veterans to Brooklyn must be filed with the Town Clerk by Thursday September 27th, 2018. **Original DD214** must be presented to the Town Clerk.

☀ **Armed Service Members: Connecticut resident in Military Service or Exemption for Federal Soldiers & Sailors Civil Relief Act** forms are available on our website and must be filed with the Assessor by December 31, 2018 for exemption to your July 2018 bill.

If you are unsure whether your project requires a building permit, please contact the building office.

Emergency Repairs: Where equipment replacements and repairs must be performed in an emergency situation, the permit application shall be submitted within the next working business day to the building official.

Expiration of Permits: Every permit issued shall become invalid unless the work authorized by such permit is commenced within 180 days after its issuance. If the project is incomplete after 180 days, the applicant must renew the permit for a fee of \$20.00.

Inspections are required by the Building Official, John Berard. Please contact the office at 860-779-3411 Extension 12 to set up an inspection date.

Town Ordinance 8-2 Withholding Approval of a Building Application When Taxes are Delinquent:

Pursuant to the authority of Public Act 95-320, it will be the policy of the Town to withhold approval of building applications when taxes are delinquent for the property for which an application is made.

Waiver. In the event that a taxpayer seeking an application is contesting the underlying tax assessment, or in cases of unusual hardship, the Board of Selectmen may waive the denial of approval set forth in this section.

(Ord. No. 95-1 State Statute 1)

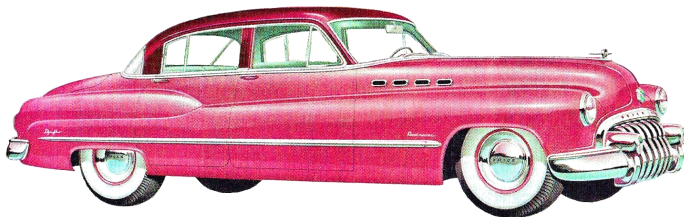

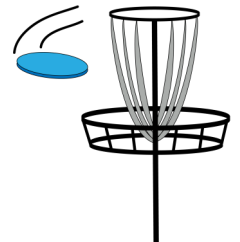

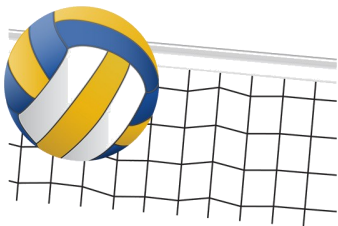

Planning and Zoning Commission Seeking Public Input on Draft Zoning Regulations

The Planning and Zoning Commission is seeking public input from Brooklyn residents, businesses, groups, and commissions on possible updates to the Zoning Regulations. With the help of town staff and planning consultant Glenn Chalder, AICP, the Planning and Zoning Commission has looked at ways to update the Zoning Regulations and make them easier to use. Mr. Chalder has assisted communities throughout Connecticut with the preparation of user-friendly zoning regulations.

The draft Zoning Regulations and Map are available on the Town of Brooklyn website.

A public information session is scheduled for **Wednesday, August 15, 2018 at 6:30 p.m.** at the Brooklyn Middle School Auditorium, 119 Gorman Rd, Brooklyn. Interested persons are encouraged to come and share their comments, concerns, and/or support. Written communications will also be accepted via email or letter. Emails may be addressed to: j.roberson@brooklynct.org.

After the meeting the Planning and Zoning Commission will evaluate the comments received and consider additional changes. Prior to adopting any regulation changes, an official public hearing would be held, possibly in the fall of 2018.

Annual Canvass and Voting History: The Registrars completed conducting the annual canvass – according to Connecticut State Statutes – beginning in February and ending in April of 2018. As of May, all registered voter records have been updated or removed to keep our official voting list accurate and up-to-date. The purpose of this activity is to update existing voter records as well as to purge voter registrations for those voters who have either moved out of the Town/State or not voted within the last 4 years.



If you have been a registered voter in Brooklyn and received our canvass mailing, please be sure to review the documents and return the canvass notice back to the Registrars with any changes/corrections noted so that you will not be removed from the Active Voter List.

General Information: The Registrars of Voters are looking for residents of Brooklyn who would be interested in becoming a certified Town Elections Moderator. We need at least 2 Democrats and 2 Republican affiliated resident voters to fill these positions in the election process. Anyone interested should contact the Registrars of Voters Office by either leaving a voice-mail message or sending an email, or personally coming into the Registrar Office on any Tuesday between the hours of 1pm to 4pm.
