Field Use Policy

If a team, league or clinic is run through or affiliated with Brooklyn Parks & Recreation Department or Brooklyn Board of Education, there is no charge during the season authorized by their governing body. Affiliated means sponsored by and under the insurance coverage of the Town of Brooklyn Parks & Recreation Dept and the Brooklyn Board of Education.

The priority of Field Reservations shall be in the following order:

1. Brooklyn Parks & Recreation Department – Teams, Clinics, Camps, and other programs/activities.
2. Brooklyn Middle School and/or Elementary.
3. Non-Profit Brooklyn Youth Sports Leagues.
4. Non-Profit Brooklyn Adult Teams.
5. Non-Profit unaffiliated, as described above.
6. For-Profit Brooklyn Teams
7. Non-Resident

Teams and Leagues in Categories 1 and 2 pay no fees.

Teams and Leagues in other categories pay according to the following fee schedule per season:

- **#3 - Non-Profit Brooklyn Youth Sports League (Brooklyn Soccer, Brooklyn Little League, Brooklyn Midget Football):** **Fall - \$500 Spring - \$500**
- **#4 - Non-Profit Brooklyn Adult Teams:** **Fall - \$500 Spring - \$500**
- **#5 - Non-Profit unaffiliated as described above:** **Fall - \$1000 Spring - \$1000**
- **#6 – For Profit Brooklyn Teams:** **Fall - \$1000 Spring - \$1000**
- **#7 – Non-Resident based Teams or Leagues (Examples: AAU Baseball/Softball Teams, Travel Soccer Teams or other traveling or AAU sports):**

Fall - \$1500 Spring - \$1500

All Tournaments for groups 3-7: \$500 per day

December – March (Start date of April 15th – weather & field maintenance permitting): No Use.
June – August – fees ?
