1. **Call to Order:** Mr. Ives called the meeting to order at 7:08pm.
2. **Approve Previous Minutes:** Bob Lee made a motion to approve the previous minutes of 9/29/2016 as presented. Bob Benson seconded the motion. Motion passed 4-0.
3. **Public Comment:** None
4. **Discussion on Financials:** The financial report covers July through October. From this point forward, the board will receive a monthly report. Revenue total is on track in the amount of \$4,419.00.
5. **Discussion on Bags:** Mr. Ives states the incorrect bags were ordered for trash, but they have Brooklyn printed on them so they cannot be returned. Mr. Ives has two bags he will bring to the landfill and see which is the better one to order.
6. **Approve 2017 Meeting Dates:** Bob Benson made a motion to set the 2017 meeting dates the last Thursday of each month, immediately following the Board of Selectmen's meeting, at the Clifford B. Green Memorial Center. Bob Kelleher seconded the motion. Schedule is attached. Motion passed 4-0.
7. **Household Hazardous Waste Update:** NECCOG received a grant to operate a household hazardous waste facility. The grant must be spoken for by July 1<sup>st</sup> or it goes away. Mr. Ives would like to invite NECCOG to a meeting to discuss their ideas and plans and how it will work for Brooklyn. Bob Lee reiterates his environmental concerns but agrees the board should have the conversation with NECCOG. Mr. Ives will arrange the meeting. In the meantime, Mr. Ives would like to arrange a one day waste day. Brooklyn has not had one in a few years.


