

As fall approaches and we think of **turning our clocks back on Sunday, November 5th**, I would like to remind everyone that it is also time to change the batteries in our smoke detectors and carbon monoxide detectors. Also make sure that you test all the detectors in your house.

Additionally, it's the perfect time to make a fire escape plan or have a fire drill to make sure everyone remembers the plan.



For all you wood burning folks, it is a great time to have your stoves and chimneys cleaned and get them ready for the season ahead. Also, please remember to burn only seasoned wood and to put ashes into a metal container. Put the ashes outside, away from your house or other structures. If you have a pellet stove, remember to keep it clean to prevent build up and increase heat output.

Falling leaves, pumpkin flavored everything, cooler temperatures, and taxes...all signs of Fall!



The second installment of real estate and personal property taxes are due this month. You can pay your bills three different ways:

- 🍁 You can mail in a check to PO Box 253, Brooklyn, CT 06234.
- 🍁 You can pay online with a credit card (2.50% fees for a credit/debit card, \$3.95 fee for a Visa Debit Card ONLY, and \$2.00 for an electronic check).
- 🍁 You can also come into the office and pay in person with check,

cash, or card (fees still apply if you pay in the office).



### **The due dates for this year's taxes are:**

October 1<sup>st</sup> - November 1<sup>st</sup> 🍁 January 1<sup>st</sup> - February 1<sup>st</sup> 🍁 April 1<sup>st</sup> - May 2<sup>nd</sup>

### **Tax Bills are Online!**

Whether you need information for income taxes or to see what you owe, you can now view your tax bills online. Here is how:

- Go to [www.brooklynct.org](http://www.brooklynct.org)
- Staying on the home page, scroll down until you see three yellow buttons.
- Click on "Online Payments." It will bring you to a link, click on the link.
- You will be brought to the search page. Type in your last name space first initial (ex. John Doe would type in Doe J).
- You will be able to see your tax bills, date(s) of payment, and how much you paid to the Town of Brooklyn during a calendar year. You can also print out your tax bills for your records.

During the month of October our staff will be conducting Building Permit and Sales Inspections and we may at times be out of the office. We recommend that you please call 860-779-3411 option 6 to insure someone will be available to assist you.



🍁 **PA 490 Applications** for Open Space, Farm Land & Forest Land are being accepted until October 31, 2017. Applications are available on our website.



🍁 **Annual Farm Building Exemption** forms need to be **notarized** and **filed** by November 1, 2017.

🍁 **Personal Property Declarations** deadline is November 1, 2017. If you are mailing your declaration, it must be postmarked by November 1, 2017. **Failure to file or filing late will result in a 25% Penalty assessment.**

**Note:** Real property or Connecticut registered motor vehicles do not need to be declared. Taxable personal property includes: **Unregistered motor vehicles, vehicles located in Connecticut but registered in another state**, horses, ponies, manufacturing machinery and equipment, business furniture and fixtures, farm machinery, farming tools, mechanics tools, electronic data processing equipment, telecommunication equipment, cable conduits, pipes, poles, business expended supplies and other such as billboards, video games, vending machines, leasehold improvements, etc.



🍁 **New Commercial Truck** applications must be completed and filed by November 1, 2017.

🍁 **New Totally Disabled/Handicapped Vehicle Exemption** forms must be filed by November 1, 2017. The form can be found on our website under Ambulance/Handicapped Vehicle Exemption.

🍁 **Armed Service Members:** Connecticut Resident in Military Service or Exemption for Federal Soldiers & Sailors Civil Relief Act, as well as In-Service Veteran's Exemption forms are available on our website and must be filed with the Assessor by **December 31, 2017.**

🍁 **New Totally & Permanently Disabled (under the age of 65)** must be filed by January 31, 2018. Proof of award is required.

Heating season is upon us once again. Please be advised that the following require a building permit. The installation of:

- ❁ Woodstoves
- ❁ Chimney liner
- ❁ Fireplace inserts
- ❁ Replacement of boilers, furnaces
- ❁ Oil tank replacement
- ❁ Replacement of electric heating elements
- ❁ Heat pumps-mini split
- ❁ Gas line
- ❁ Pellet stove
- ❁ Generator
- ❁ Water heater replacement

Once the installation is complete an inspection is required by the Building Official, John Berard. Please contact the office at 860-779-3411 Extension 12 to set up an inspection date.

Town Ordinance 8-2 Withholding Approval of a Building Application When Taxes are Delinquent:

Pursuant to the authority of Public Act 95-320, it will be the policy of the Town to withhold approval of building applications when taxes are delinquent for the property for which an application is made.

*Waiver.* In the event that a taxpayer seeking an application is contesting the underlying tax assessment, or in cases of unusual hardship, the Board of Selectmen may waive the denial of approval set forth in this section.

(Ord. No. 95-1 State Statute 1)





🍁 **Election Day Registration (EDR)** will be available from 8:00am to 8:00pm at the Registrar's Office at the Brooklyn Town Hall.

🍁 **General Information** – The Registrars of Voters are looking for residents of Brooklyn who would be interested in becoming a certified Town Elections Moderator. We need at least two Democrats and two

Republican affiliated resident voters to fill these positions in the election process.
