NOW, THEREFORE, BE IT RESOLVED that the Town of Brooklyn, through its Board of Selectmen does herby authorize the First Selectman to petition the Secretary of the Connecticut Office of Policy and Management to remove the Town from eligibility under the Urban Act and seek eligibility under the Small Town Economic Assistance Program.
