
1. Call to order

5. Review the 2 requests from the town Highway Department. Tom Rukstela and First Selectman Austin Tanner will explain and answer questions on the 2 items.
 - a. Replace Highway Department Foreman's 2015 4-WD pickup truck with new one with plow. Old truck will remain in Highway department fleet as a support truck replacing the existing 1997 F-250 Ford pickup which will be scraped or sold - - - - \$70,000.
 - b. Replace existing 2013 JCB Loader tractor w/backhoe from a different manufacturer. This unit has cost the town over \$10,000.00 in repairs this year alone and still is not perfect. This would cost the town approximately \$140,000 to replace less what we get for a trade-in allowance on the old unit.
6. Review the 3 requests from the Parks and Recreation Department for this year's capital. Mike Gaudreau will make the presentation and answer questions.
 - a. Resurface Prince Hill basketball court \$10,000-15,000.
 - b. Construct new Tennis/Pickleball courts at Price Hill \$150,000-200,000.
