Land Use News

State and Town Cooperate to Protect Farmland from Development

In April, Brooklyn citizens voted to acquire the development rights to 50 acres on Barrett Hill Road. The property is notable for its abundant natural resources. It is adjacent to existing preserved land and has fertile farmland soils, a significant wetland complex, wildlife corridors, and a scenic vista. The State of Connecticut Department of Agriculture will pay 75% of the cost of an Agricultural Conservation Easement that ensures that the property can never be developed. The Town of Brooklyn will fund the remaining 25% using the Open Space Acquisition Fund.

Village Center District Revised

In March, the Brooklyn Planning and Zoning Commission voted to revise the Zoning Regulations for the Village Center District which includes the Town Green National Register Historic District and adjacent properties near the intersections of Routes 6, 169, and 205. The Town of Brooklyn was the first town in Connecticut to adopt a Village Center District. The commission rewrote the regulations to streamline the process for homeowners and businesses in the district that need to make minor changes to their property. It will also make it easier for businesses to relocate to the Village Center District while maintaining important design standards.

Transfer Station

Friday: 10am-5pm Saturday: 8am-5pm Is your spring cleaning finished and now you don't know where to get rid of your unwanted belongings? Here is a list of some the items that are accepted at the transfer station: tires, propane tanks, refrigerators/freezers (doors must be removed), couches, chairs, mattresses, boxsprings, metals (ex. scrap, wire, fencing, washers, and dryers), brush, leaves, paint (oil and latex paints can be collected, please see Transfer Station Attendant before going), and electronic waste. Please visit the Transfer Station's website or call them for more information and prices.

Municipal Solid Waste: This is household garbage and should be placed in Green Town of Brooklyn bags and disposed of in the compactor. Bag cost is \$10.00 per roll of five 33 gallon bags, \$7.00 per roll of five 17 gallon bags, or purchased individually for \$2.00 each.

Bulky Waste: Any debris such as construction, demolition, or land clearing waste. This should be weighed at the scale hose and disposed of in bulky waste containers at \$0.10 per pound.

Emergency Management and Homeland Security Committee



The Town of Brooklyn Emergency Management and Homeland Security Committee is working hard to ensure that the Town is prepared for any potential hazard. This past month we brought to the Brooklyn Ag Days a Department of Public Health Mobile Field Hospital to serve as a respite station during the event. Throughout the weekend, we had cots and air conditioning available to anyone who may have needed a break from heat or was in need of medical assistance. It was staffed with personal

from Mortlake Fire Department, the Medical Reserve Corp, Department of Public Health, and Department of Corrections Officers. This is but one of many examples of what we are doing in Town to mitigate, prepare for, respond to, and recover from any and all hazards that could affect our residents.

As the summer is upon us, here are a few helpful tips to be prepared for the summer weather:

- With weather that can change rapidly, it is important to be aware of potentially hazardous weather. One way is to download an app for your smart-phone that will alert you to bad weather as it approaches. FEMA just launched its own app that will forward weather alerts to your phone. The Red Cross also provides similar apps for your smart-phone as does WFSB and NBC 30 News.
- Stay hydrated. It is incredibly important to drink enough water especially as the temperatures rise in the

Real estate, personal property, motor vehicles, sewer, and fire taxes are all due this month. You can pay your bills three different ways:

- You can mail in a check to PO Box 253, Brooklyn, CT 06234
- You can pay online with a credit card (2.50% fees for a credit or debit, \$3.95 fee for a Visa Debit Card ONLY, and \$2.00 for an electronic check).



• You can also come into the office and pay in person with check, cash, or card (fees

still apply if you pay in the office).

The due dates for this year's taxes are:

July 1st – August 3rd
October 1st – November 2nd
January 1st – February 1st
April 1st – May 2nd

Sewer Usage Bills issued this year will be on **green paper**, so as not to be confused with the Fire District Tax Bills that are printed on yellow paper.



If you have not received a tax bill for an item that you owned as of October 1, 2014, please call the Tax Office to find out what is due.

Motor Vehicles

Have you sold or gotten rid of your vehicle? If so, you might be eligible for an adjustment! Please bring in one of the below mentioned forms to the Assessor's Office to see if you are eligible! Please note that the following forms of proof must specifically identify the vehicle in question by make, year, and vehicle identification number.

Following forms of proof are acceptable:

- Plate receipt from the Department of Motor Vehicles
- Statement from insurance company telling us when and *why* the insurance was cancelled.
- Statement from junk dealer, car dealership, etc. showing when they purchased the vehicle.
- Copy of larceny report stating the car was stolen and never recovered.
- Copy of your original validated registration from the state in which you now reside.
- Copy of the bill of sale, dated and signed by seller and buyer.

Please Note: Unregistered motor vehicles are still taxable under Connecticut State Law and must be declared as personal property.

Tax Bills are now Online!

Whether you need information for income taxes or to see what you owe, you can now view your tax bills online. Here is how:

- Go to www.brooklynct.org
- Staying on the home page, scroll down until you see three yellow buttons.



- Click on "Online Payments." It will bring you to a link, click on the link.
- You will be brought to the search page. Type in your last name space first initial (ex. John Doe would type in Doe J).
- You will be able to see your tax bills, date(s) of payment, and how much you paid to the Town of Brooklyn during a calendar year. You can also print out your tax bills for your records.

Applicants must submit their SSA 1099 from Social Security and proof of any other income, Federal Income Tax form, if you were required to file, rent receipt for the entire year, and information from Eversource (CL&P). **All information must be for the 2014 year.** Please call 860-779-3411 option 6 for an appointment.


On September 1, 2015, we will begin to accept applications for PA 490, Open Space, Farm Land & Forest Land. Applications are available on our website at www.brooklynct.org. Because our town is currently being reevaluated, the application period is extended until December 31, 2015.

Personal Property forms will be mailed by September 30, 2015 and are due November 2, 2015.

The Additional Veteran's Program continues until October 1, 2015. You must provide all income for **2014**, including a Federal Income Tax, form if you were required to file.

Honorable Discharge for new Veterans to Brooklyn must be filed with the Town Clerk by September 30, 2015. The **original DD214** must be presented to the Town Clerk.

Tyler Technologies continues to work on our town wide revaluation. All property owners will be notified by mail in the Fall of their new assessments for the 2015 Grand List, which will be reflected in the July 2016 tax bills.
