- 1. Call to order Bill called the meeting to order at 7:00pm.
- 2. Approval of Minutes
 - a. November ⁴7, 2022 Aaron made a motion to accept the minutes as presented. Richard seconded. Motion passed 4-0-0.

 - a. Training
 - WEBEOC State is doing some training on WEBEOC which is the software used to communicate regionally. During the day and probably online. Bill will get interested individuals signed up.
 - b. CERT Training Citizen Emergency Response Training. Bill recounted that many towns had separate teams. The regional EMDs are now looking at a regional CERT team to cover Brooklyn and neighboring towns.

 - d. EMPG Grant
 - i. 2022 grant Grant by the State for supplies and equipment. Resubmitted the paperwork for about \$7,000 and has had no response.
 - e. Update publications Bill spoke with other EMDs about publications. He has hope that he will have time to update.
 - f. Future projects/goals for the commission
 - EOC Support If there is a storm that we think will be significant Bill hoping that people will reach out to volunteer.
 - ii. Inventory This has not been started. Holidays were busy.

 - a. Recent activities No recent happenings. Bill did apply for an ARPA grant to replace the radios. Hoping to hear back soon. Bill filled out paperwork that will connect radios to the State Police system as well as other local departments.
 - b. Upcoming winter season –There is nothing severe forecasted as of now.
 - c. Northeast EMD Meeting 1/10/2023 There was a presentation from NEHD. If there is a bioterrorism event and medications needing to be distributed, they are working on a plan. Each town will then get the supplies to their towns. Will work with NDDH to distribute. Theoretically as we did test kits and masks at the fairgrounds. There was another meeting regarding State training program on March 27-28 at the fire facilities in Willimantic. It's specific to each town's needs. The State is also reviewing regional shelters. School safety programs are being reviewed as well.
 - d. LESOP due in 2024 It's a biennial report. Bill will go back through the process at some point this year to update.
 - e. Reunification Drill at the School The drill mimicked a disaster event at the school. The school will shut down. Parents won't be able to get access to the school so that authorities can get through. Students will be removed from school, take them somewhere safe and reunite them with their parents. It addressed where additional responders may be needed.
