After discussion, Sandra Brodeur made motion to hold a special meeting on 5/1 at 7pm to hear capital recommendations and begin consolidation. Drew Dionne seconded the motion. Motion passed 4-0.

- **4. Presentation of General Government Budget:** Mr. Ives presented the general government budget outlining specific budgets with changes. All salaries include last years increase as well as this year. This is because negotiations were not finalized before the budget was.
 - 4101 Increased for oversight
 - 4117 ½ cost of finance director. Mr. Ives has met with Ms. Buell to discuss the structuring of the finance department and to hire a person who would act at Ms. Buell's executive assistant and as human resources for both the Town and School. This position has been offered and accepted. Most of the salary will be in the school, only a small portion with the Town.
 - 4131 Increased the Assessor to full time. Mr. Ives will send a salary schedule to the board.
 - 4151 The current ZEO is retiring. Her position is currently 3 days, this may go to 4.
 - 4173 Part time wages were removed
 - 4181 The internet was upgraded, and this saved money

- 4185 The majority of copiers are now leased
- 4201 The State is still billing the Town for only 85% of the Resident Trooper's salary
- 4303 This increase is for a part time plow driver
- 4899 This increase is due to interest and payments on capital projects and grants. There is also a new payment installment to Woodstock Academy
- 4317 Disposal charges have increased

Mr. Ives states the Fire Marshal needs new fire codes, the current ones he is using are 20 years old. Mr. Ives will make adjustments and bring the revised budget to the May 1st meeting.

Drew Dionne made a motion to receive the general government budget for 2019/20 and hold for further discussion. Sandra Brodeur seconded the motion. Motion passed 4-0.
