L. Brodeur stated that the new ambulance will be ready in May and the final cost is \$341,528.00, that \$260,000.00 was received, so they are short \$80,000.00. This was discussed at length by the Committee, and it was stressed that project budgets have already been approved, and if current estimates are over budget, recipients of funds should not overcommit to the funds they have been allotted and assume that ARPA will pay the difference. The Board talked about providing the remaining funds to applicants already approved if there is a need for additional funds. D. Lee made a motion that we send correspondence to the outstanding awardees with a deadline of April 1st to provide us concrete information on the progress toward the expenditures of those funds, whether they need more funds and how much, or if they are going to return funds. L. Brodeur seconded; J. Voccio stated that they need to make sure it is funds for their original request and not anything additional, etc.; and the motion passed. A. Tanner stated we would get the letters out next week. He also said he would check on dates for the next meeting.
