Brooklyn Fire Commission:

I am addressing the Commission this evening to make certain you are all aware of the ongoing discussions that my husband and I have been having with the First Selectman Austin Tanner regarding the Brooklyn Fire District. We have provided action items to Selectman Tanner that we would like to see accomplished but to date have not received. We are hoping by bringing them to the attention of this Commission we can see some movement on any or all of the items.

Action item #1

We are requesting the town follow up with the Brooklyn Fire District and or Attorney McCoy regarding our recent FOIA request to the Brooklyn Fire District, and the fact that they are a in fact a public agency who is required to comply with FOIA requests.

Attorney McCoy states in part "It is the position of the Brooklyn Fire District, Inc. that it is not a public agency as defined by FOIA, required to produce the documents which you requested." (full email attached)

a. We contest that claim and say: The Brooklyn Fire District is a Special Taxing District.

The "Independent Special Taxing Districts in the State of Connecticut" document states that (page 10 attached)

"The full gamut of freedom of information statues apply to special districts."

b. In addition, the Brooklyn Fire Districts own by-laws state:

Section 2.

"The district board's duties, which are required for operation and management of the district, are set forth in these by-laws and pertaining to resolution of the General Assembly of the State of Connecticut...

and

Section 3.

"The District Board Shall abide by all resolutions passed by the General Assembly of the State of Connecticut."

*These are from the 2021 by-laws since the 2022 do not appear to be filed with the town hall yet.

c. It should also be noted that Attorney McCoy uses a different name and mailing address nearly every time he writes about or files documents on behalf of the Brooklyn Fire District. In this particular email he references to them as the Brooklyn Fire District, Inc. which is an organization that does not exist.

Action item #2

Town of Brooklyn to follow up with Attorney Rule regarding October 26, 2022 EBFD Facebook post where Chief Pepin wrote (in part):

"This Fire Department was placed on this lawsuit illegally. Department by-laws were not followed, and an attorney was hired to represent the department by past leadership with no vote by the membership. Per our department by-laws the Fire Chief has no authority to conduct business on behalf of the fire department. The only representative with that authority is the department president. Again, the department members did not vote to be placed on this lawsuit. The Brooklyn Fire District and the East Brooklyn Fire Department are two separate entities.

The EBFD can perform its own action here action item regarding the statement above. They can request that they be discharged from Attorney McCoy's representation of their department in the lawsuit.

Action item #3

The town of Brooklyn to follow up conversation/action regarding our lengthily discussion last week with Fire Marshal Doug Kramer regarding the validity of the "Fire Lane" on the easement as well as the "No Parking Fire Lane" signs on South Main Street.

I strongly urge this Fire Commission to make a statement to the Board of Selectman regarding the above-mentioned items. Each day that goes by without action costs the town of Brooklyn and its taxpayer's more and more money. For example: we spent hours on the phone today with our attorney regarding the case — we were specifically discussing the fact that Brooklyn Fire District President William Wheaton Sr. has opposed our liquor license due to "lack of parking". For Citizens to be repeatedly told that there is no new action taking place towards our business is a fallacy.

A note to the Commission that is not relevant to the lawsuit but we feel is equally important:

Earlier this year it was brought to our attention by a town employee that current fire department building was located outside of the Brooklyn Fire District. After learning this we looked into the meeting minutes and such to see how the District was allowed to purchase property outside of the district back in 2003. When we couldn't find anything on the minutes or a record of a mortgage ourselves, so we inquired with the town clerk. Her response is as follows:

"Unless it's under a different name, there's no record of a mortgage or release under Brooklyn Fire District recorded on the land records."

We bring this up as concerned citizens since there are strict laws governing the bonding of public buildings. Even if everything with the District is on the up and up, the fact alone that the documents are not easily accessible in records for the public to review or to be found by the town Clerk is alarming.

I could go on all night with all the things we have uncovered, and we have shared all of this already with the First Selectman. But the fact of the matter is that in the best interest of this Fire Commission and the Town of Brooklyn to take a deep dive into the Brooklyn Fire District to make sure that they are in compliance with all policies and procedures set forth by the State of Connecticut.

I am asking you here tonight to be the people to take that dive.

I have attached nine pages of documents in support of this statement and ask that they be entered into the public record in their entirety along with this two-page statement I will email them all to the recording secretary.

Re: Item 1

Legal Requirements on Connecticut Districts

In addition to the provisions of chapter 105 and any special act provisions, special districts, by their nature as political subdivisions of the state, are subject to numerous other state statutes. The following are identified as clearly being applicable. Additional laws may also have applicability in some or all cases.

- Freedom of Information (CGS 1-18a to 1-21k). The full gamut of freedom of information statutes apply to special districts. This includes such areas as notices, meetings, minutes and access to public information and documents. In fact, since the FOI law was adopted in 1975, there have been 14 decisions in cases involving special districts, 13 of which found fault with district operations. One case was dismissed. None appears to have involved major, willful violations, nor did any result in fines or penalties. The issues most prevalent involve: (a) meeting notices and agendas; (b) executive session requirements; and (c) production and availability of meeting minutes and other public documents.⁶
- Public Records Storage and Handling (CGS 1-7 to 1-19). All of the statutes which pertain to the preparation, protection and storage of public records apply to special districts. There are requirements that all permanent records be printed on paper and with ink specified by the State Administrator of Public Records. They must be stored in fireproof, locked facilities which assure their protection, and copies must be provided to the public at reasonable fees. This set of statutes is probably one of the least understood and most frequently violated of all statutes by districts (as well as by most other governmental agencies).
- 3. <u>Municipal Auditing Act</u> (CGS 7-391 to 7-397). Each district must keep financial records in accordance with state law and provide reports as required. Details of this statute are discussed in the Accountability Section of this report.
- A Bonding Act (CGS 7-369 to 7-380a). Any district borrowing funds on a long term debt basis must do so in accordance with the Municipal Bonding Act. Informal borrowing procedures which can be practiced by private agencies are not allowed for public

ARTICLE I

MISSION STATEMENT


The Brooklyn Fire District Committee shall provide for the proper administration and safety of the Brooklyn Fire District, which is located in the community known as East Brooklyn. This shall be done primarily through its support of the East Brooklyn Fire Department. This shall also be done by maintaining tax collection procedures along with spending and saving authority on behalf of the District taxpayers.

ARTICLE II

DUTIES OF THE BOARD OF DIRECTORS

- Section 1. Shall be comprised of the following officers by their titles:

 President, Vice-President, Clerk and Treasurer. A maximum of five directors shall also comprise the district board as members but are not considered as officers.
- Section 2. The district board's duties, which are required for the operation and management of the district, are set forth in these by-laws and pertaining to resolution of the General Assembly of the State of Connecticut passed at its January session 1899 and approved March 15, 1899, and as from time to time may have been amended. The purposes of the district are more particularly detailed in C.G.S. 7-326.
- Section 3. The District Board shall abide by all resolutions passed by the General Assembly of the State of Connecticut.
- Section 4. The District Board shall review the by-laws of the Brooklyn Fire District once a year prior to the annual District Meeting and present revisions at said meeting for approval, or the District President may call a special meeting at any time for said purpose.
- Section 5. Changes to the District by-laws shall be done following the process listed below:

I am writing this statement on behalf of the East Brooklyn Fire Department and with permission from the fire department President. This statement has no reflection on the Brooklyn Fire District as they are their own separate entity. I have been the Fire Chief here in East Brooklyn for the last 8 months. It has taken me this long to wrap my head around this on-going situation with the Ice Box. Let me be clear with the information that is not being disseminated. It is very unfortunate that we have been placed in this position due to the negligence of the past leadership of this organization. This Fire Department was placed on this lawsuit illegally. Department bylaws were not followed, and an attorney was hired to represent the department by past leadership with no vote by the membership. Per our department by-laws the Fire Chief has no authority to conduct business on behalf of the fire department. The only representative with that authority is the department president. Again, the department members did not vote to be placed on this lawsuit. The Brooklyn Fire District and the East Brooklyn Fire Department are two separate entities. As the Fire Chief I have no authority or say when it comes to the Brooklyn Fire District, as they are above me. I represent the membership only. However, with all of this being said, I am quite saddened and disturbed over statements made towards my members over the past week and 24 hours. 90 percent of my membership have no desire to be a part of this. As a matter of fact- the majority of them were not members when all of this started. Over the past 8 months we have obtained some new membership, including cadet and junior members. Members have been harassed in local establishments, in public, and on social media. We have received harassing messages on our own social media. My junior membership (all under 17 years old) has had to deal with negative comments in public. I have had to cancel public relation and fund-raising events because I refuse to let my membership be berated in public. All in which 90 percent of our volunteers have had nothing to do with any of this. I find this entire situation to be absolutely disgusting. In the past 8 months there has never been an instance where a member has spoken to or harassed any patron of the Ice Box. As a leader, I understand that it is my responsibility to take the blow of this mess that was left behind. However, I feel incredibly sad for the hard-working men and women of this organization that continue to answer the call for service despite all of this negative attention. I am so proud of their resistance to respond in public and on social media. They are proud to display East Brooklyn Fire Department on their clothing and should do so without harassment. We will keep moving forward and serve the public we protect with respect and compassion. The East Brooklyn Fire Department is continuing to move forward to resolve this on-going issue. Thank you.
