Good evening,

My name is Jennifer Nemeth and most of you present thins evening are already aware that my husband and I are being sued, along with others, including the Town of Brooklyn by the East Brooklyn Fire Department and the Brooklyn Fire District.

After years of waiting for action that was promised from public officials we have now taken matters into our own hands and I have been regularly attending town meetings as a plea for help from the boards and committees but also by way of the meeting minutes going to the public. Yes, our plea is primarily about wrapping up this insane lawsuit but in addition I am raising issues we have found as a result of our lawsuit discovery.

Tonight I again want to raise the issue of mismanage funds on behalf of the EBFD and the Brooklyn Fire District. I submit supporting documents to that effect as well.

Issue # 1:

Facebook post from EBFD Fire Chief Brian Pepin in which is states in part:

This Fire Department was placed on this lawsuit illegally. Department laws were not followed, and an attorney was hired to represent the department by past leadership with no vote by the membership..."

It seems to me like this is an issue the Town should want to both rectify immediately and investigate who is financially responsible for the actions this illegal lawsuit has caused.

## Issue # 2

I am attaching emails from town officials regarding questions we have raised regarding the "mortgage" at 15 South Main Street. As a result of the discovery process in defending ourselves in the lawsuit we have reason to believe there is a major issue regarding the mortgage for the District. We have been asking for the public records since February and have received no results. The most recent comment this week from the First Selectman is that the mortgage issue is "fuzzy".

According to the Brooklyn Fire District's Annual Meeting Minutes from May 2, 2022: "I[n] the past year we have had some changes going on, we paid off the mortgage and we appointed a new Chief..."

**From the Town Clerk:** "Unless it's under a different name, there is not record of a mortgage or release under Brooklyn Fire District recorded on the land records."

**From the Finance Office:** "I can say, we do not have any documentation in our current records for either obtaining the mortgage or paying off the mortgage..."

A ask this commission to not accept "fuzzy" as an answer anymore. The public deserves to know how that mortgage was obtained, who received the mortgage interest all these years, and receive the documents regarding the "pay off".

When I sent an FOIA request to the Brooklyn Fire District I was informed by their attorney "It is the position of Brooklyn Fire District, Inc. that it is not a public agency or agency as defined by FOIA, required to produce the documents which you requested..." I have been working to prove otherwise to their agency and I request this Board help me do the same for the sake of the town.

I thank you in advance for your time and attention to these matters. I ask that this statement be entered into the public records, including seven pages of attachments. I will send hard copies of all this to the recording secretary for her records.





Attachment #1 Complete EBFD Facebook Statement from Chief Pepin posted October 26, 2022:

I am writing this statement on behalf of the East Brooklyn Fire Department and with permission from the fire department President. This statement has no reflection on the Brooklyn Fire District as they are their own separate entity. I have been the Fire Chief here in East Brooklyn for the last 8 months. It has taken me this long to wrap my head around this on-going situation with the Ice Box. Let me be clear with the information that is not being disseminated. It is very unfortunate that we have been placed in this position due to the negligence of the past leadership of this organization. This Fire Department was placed on this lawsuit illegally. Department bylaws were not followed, and an attorney was hired to represent the department by past leadership with no vote by the membership. Per our department by-laws the Fire Chief has no authority to conduct business on behalf of the fire department. The only representative with that authority is the department president. Again, the department members did not vote to be placed on this lawsuit. The Brooklyn Fire District and the East Brooklyn Fire Department are two separate entities. As the Fire Chief I have no authority or say when it comes to the Brooklyn Fire District, as they are above me. I represent the membership only. However, with all of this being said, I am quite saddened and disturbed over statements made towards my members over the past week and 24 hours. 90 percent of my membership have no desire to be a part of this. As a matter of fact- the majority of them were not members when all of this started. Over the past 8 months we have obtained some new membership, including cadet and junior members. Members have been harassed in local establishments, in public, and on social media. We have received harassing messages on our own social media. My junior membership (all under 17 years old) has had to deal with negative comments in public. I have had to cancel public relation and fund-raising events because I refuse to let my membership be berated in public. All in which 90 percent of our volunteers have had nothing to do with any of this. I find this entire situation to be absolutely disgusting. In the past 8 months there has never been an instance where a member has spoken to or harassed any patron of the Ice Box. As a leader, I understand that it is my responsibility to take the blow of this mess that was left behind. However, I feel incredibly sad for the hard-working men and women of this organization that continue to answer the call for service despite all of this negative attention. I am so proud of their resistance to respond in public and on social media. They are proud to display East Brooldyn Fire Department on their clothing and should do so without harassment. We will keep moving forward and serve the public we protect with respect and compassion. The East Brooklyn Fire Department is continuing to move forward to resolve this on-going issue. Thank you.

-Per section 7-328 of the Connecticut General Assembly Public and Special Acts we are

requesting the Tax District and/or The Town provide a copy of the request made by the Fire District when they obtained funding for the "mortgage" at <u>15 South Main Street</u>.

See 7-328 taxation and bonds:

"...Theclerk of the district shall give written notice to the treasurer of the town in which the district is located of any final decision of the board of directors to borrow money, not later than thirty days after the date of such decision. The district may adopt ordinances, with penalties to secure their enforcement, for the purpose of regulating the carrying out of the provisions of sections 7-324 to 7-329, inclusive, and defining the duties and compensation of its officers and the manner in which their duties shall be carried out."

Lastly per the May 2, 2022 Brooklyn Fire District annual meeting minutes stating that the mortgage at <u>15 South Main Street</u> was "paid off" we are requesting from the District and or the Town, documentation to that effect.
