- IV. Review minutes from September 27, 2022 meeting.

Motion was made by C. Langevin to accept the Minutes of the September 27, 2022, as presented. Second by L. Brodeur.

Ms. Rosinski suggested doing a bee program. It was decided to try to put together a program with Logee's in the spring, to also involve the public. Mr. Brodeur suggested finding our whether it would be possible to expand the program by also touring Logee's.

There was discussion regarding the Celebrating Agriculture Event at the Fairgrounds (September 23, 2023). The Commission will try to set up a booth and show the video(s). Ms. Ennis may be able to provide a calf or a cow for the day (someone would need to stay with it).

There was discussion regarding which farm(s) will be videoed next.

Mr. Langevin will be planting in mid-to-late March. Ms. Ennis will provide Mr. LeBlanc's phone number so they can coordinate.

There was discussion regarding whether you need to get the permission of people who appear in the video, that were present during filming. Ms. Rosinski suggested a disclosure for the responsible party to sign. Mr. Langevin will consult an attorney.

There was discussion regarding Walktober. October is a very busy month for Mr. Langevin.

Ms. Brodeur commented that it would be good to get video of the farms during all of the seasons to post on the website to show what is available.

Mr. Brodeur suggested budgeting for a kiosk to use at the different events. Ms. Brodeur will research prices.

Ms. Brodeur suggested keeping an eye on what the Conservation Commission is doing to see if there is something that the two Commissions could work on together.
